BENEFITS GAINED BY SERVING THROUGH CEHS

Given the vast number of available entities in need for services, makes selecting a few to serve a daunting task. CEHS makes its selection through an objective and consistent process. The annual selection comes from a pool of entities identified by the Society members. This pool goes through an evaluation process intended to identify those entities that are most effectively aligned with the Society objectives accepted by the members. Available resources are then allocated among the announced selection of entities in the following order: (1) Members’ explicit preferences, (2) the Executive Committee decision in cases of no preference given.
